To whom it may concern in CA court,

I am a court hall chaplain in Gwinnett County courthouse for 15 years. It has been my privilege to serve those who are in their darkest hours of desperation. The court hall / court room is the heated oven of Gwinnett Co. **seeking not to change one's surroundings of others but their own character of heart from bitterness, and pride to forgiveness, reconciliation, and restitution.**

The greatest weapon ever to accomplish this that cuts to the heart the core and character of us all is **perseverance in prayer and forgiveness in love.** My initiated prayer in the court halls is welcoming the CEO and Attorney of the Universe, Christ Jesus, to plead their case before God, the Judge of all judges. Prayer also is the humble recognition that their **"best performance"** has messed up their relationships and unfit for LOVE - the very things they have longed for their entire life. **God has to bring us all down to NOTHING to reveal to us all He is up to SOMETHING BIG.**

This is the background where on April 30th I met Jonathan and Remi Jordan in Gwinnett County court after they left the courtroom. I introduced myself as the Chaplain and offered that I could pray with them concerning their case. They agreed to pray together, however Jonathan was visibly agitated during prayer and after. **Over the years I have observed that when prayer in unwelcomed, the spirit of rebellion and pride is still at work "in the oven" and unfit or not ready for repairs.**

The spirit of rebellion through domestic child physical and sexual abuse violence was confided to her through her eldest daughter. Under these circumstances is evident where the true issues are at stake. Yet God is mightier than any such conditions is why she has told me she still wanted to pray for his healing of bitterness, wholeness in forgiveness, and restoration in reconciliation.

Remi (wife) is focused not to the immediate circumstances, but on acceptance and acknowledgement that God can change what people think is impossible to occur. She is a woman of faith praying earnestly for her husband in the midst of his personal struggles of pride and rebellion that prevents us from our goal of a healthy and peaceful life upbringing for the girls.

She has expressed to me being a tremendous help to her and our children. From praying together several times to providing wisdom, encouragement, and sharing my experiences and what God has shown me. She was eternally thankful for that one day of divine visitation in dedication and persistence in my purpose and calling to help in sharing what God's laid on your heart.

Her heart's desire is to waken her own righteousness and truth in the midst her adversities. Her story is a **"victor survivor" rejecting being victimized.** I told her that God has chosen her to use her adversities to help others in similar circumstances.
