What God has done for thousands of years our federal and state governments are finally catching the **same joy** He has literally watching a transformed second chance life succeed.

Georgia Governor Brian Kemp has issued a Proclamation declaring April as **Second Chance Month in the State of Georgia**. In his Proclamation, the Governor acknowledges that in the State of Georgia the number of legal collateral consequences of a criminal conviction is close to 1,000. These collateral consequences include denial of housing and employment opportunities. These barriers can contribute to recidivism, which increases victimization and decreases public safety.

The designation of April as Second Chance Month contributes to increased public awareness about the need for closure for those who have paid their debt, and opportunities for individuals, employers, congregations, and communities to extend second chances.

My family couldn't thank you more. Thank you for all you've done for my family. You saved my marriage eight years ago. You invited us into your church and everyone there was so welcoming. My husband came to the church and participated in your man's group. He found purpose in donating to a homeless man and coming together with you all. I found more wisdom from the life group and appreciated the focus on the bigger picture of living right by God.

My husband and I faced many challenges in our marriage. I were contemplating divorce. It wasn't until You said to us, *"If you're not right with your husband you're not right with your God, and if you're not right with your wife you're not right with God."* Those words gave me so much clarity in everything I do as a wife. Since then my marriage has been amazing.

But in January 2017 I was diagnosed with an aggressive cancer. I had to be in the hospital every 5 two weeks for 5 day straight and away from my family. This tested my faith, but my husband would sleep in that hospital bed right next to me. My family stood strong and prayer was so powerful and positive. I was in remission in October 2017 and three months later I was diagnosed again with the same aggressive cancer in January 2018.

I called you, just to say hello and when our call ended you prayed for me as you always do. I had many treatments and a stem cell transplant and still had the cancer in January 2019. I contacted you again just to talk and pray. **I'm now in remission since October 2019.**

My husband is so sweet, so attentive, and a true reflection of me. People tell us all the time they can't wait to have what we have! They think we are newlyweds! They can see how happy we are! I have you to thank for that. Thank you for saving my marriage 8 years ago.

In addition to you saving my marriage. My husband has spent time helping me get closer to my calling and purpose that God has given me. I've been singing since I was a child and have been told my voice is amazing and angelic. He worked very hard and made it possible for me to purchase a home studio to sing and praise the Lord.

God by far is a Way Maker. I'm glad that he had a divine intervention and made us cross paths with you before we were married at the courthouse, after we were married at the courthouse, and then again in public when we were married. It's just amazing what God puts in front of you until you finally see it. God bless you.
