## GOD'S APPEAL TO CIRCULATE CHRISTIAN BOOKS DORMANT IN YOUR HOMES !

#### **START OF BOOK DRIVE IN YOUR CHURCH.**

THE **CHRISTIAN** LIBRARY INT'L of surge demands. During 2019, CLI sent a quarterly box of Bibles and Christian books to approximately 1300 jails, prisons and youth detention centers located in all 50 states. A total of 160,366 Bibles and Christians books were packed into those approximately 5200 boxes. 2340 inmates have written to CLI to share that they accepted Jesus Christ as their Savior as a result of Bibles and Christian books received from CLI., CLI received and reviewed 15,600 Bible study lessons from inmates. CLI makes available to the inmates 3 specially prepared Bible Study Courses in both English and Spanish. 9420 inmate letters were answered by a special team of volunteers.

Their Buford shipping Center sends a quarterly boxes of materials to nearly 400 of the 1300 prisons. Our most recent accounted records of delivery to CLI was 24 Bibles, 286 Christian books, 245 pamphlet/devotionals, 40 magazines, and 168 CD/DVDs.
